Provide proper and timely reports to the Accounting Officer on the state of risk management, together with aspects requiring improvement accompanied by the Committee's recommendations to address such issues; Perform any other duties of the Risk Management Committee as specified in the Terms of Reference (Committee Charter).

Oversee and discharge responsibilities as contained in the Audit, Risk and Performance Committee Terms of Reference (Charter) on a quarterly, ad hoc and annual basis.

MINIMUM EDUCATIONAL QUALIFICATION AND EXPERIENCE

Applicants should be in possession of a relevant Bachelor's Degree at NQF level 8 in Risk Management or Business Administration. An active member of the Institute of Risk Management (SA). CA/MBA will be an added advantage.

The ideal candidate should have ten years of Risk Management experience, preferably in the Public Sector.
